## **TASK FORCE ITEMS**

### **I. Coast to Coast Connector Trail – Status of Segments and Phases**

TJ Fish provided updates on the Coast to Coast Connector Trail including status of segments and phases. Various locations of restrooms, bike repair areas, and drinking water facilities were discussed. Gallus Quigley provided an update on the county wide Trails Master Plan and the upcoming meetings that will be scheduled across the county. He added it is important they receive the cities and public input.

TJ Fish provided updates on East Avenue project in Clermont and Broad and Grove thru downtown Groveland.
