At the December TDCB meetings, staff discussed the study undertaken by the University of South Florida's Center for Urban Transportation Research (CUTR) to explore Florida's historic funding of transportation for the disadvantaged. Staff will provide an update on the findings of the study.

E. <u>Lake County ADA Advisory Committee</u>

The ADA Advisory Committee advises the Lake County Transit Division on practices, services, and policies related to meeting the transportation needs of customers with disabilities. The National Transit Institute provided ADA Eligibility training in Tampa on January 12 and 13. This training provided hands on guidance on accessing those with disabilities. Travel training was provided to students and teachers at Gray Middle School in Groveland on March 2, and to Tavares Middle School students and teachers on March 7. The Travel Training Program continues to grow in popularity.
